Orex Minerals Grants Options

Vancouver, BC – Orex Minerals Inc. – (TSX.V: REX – OTCQB: ORMNF) ("**Orex**" or the "**Company**") announces that it has granted an aggregate of 3,425,000 incentive stock options to directors, officers, and consultants to purchase up to 3,425,000 common shares in the capital of Orex. As a result of this option grant, Orex has 11,850,000 stock options outstanding, representing 9.7% of the issued and outstanding share capital of the Company.
